Insolvency proceedings Anglo Austrian AAB AG, 5 S 29/20d

Dear Sirs,

As you are probably already aware from the media, insolvency proceedings regarding the Anglo Austrian AAB AG, formerly Anglo Austrian AAB Bank AG or Meindl Bank AG, have been initiated by order of the commercial court of Vienna dated 2nd March, 2020, 5 S 29/20d. I was appointed as insolvency administrator in these proceedings.

The opening of insolvency proceedings represents an event within the meaning of § 9 ESAEG. As depositors of Anglo Austrian AAB AG, your deposits are covered by the deposit guarantee up to a maximum amount of EUR 100.000,- per depositor and institution (§ 7 Abs. 1 Z 5 ESAEG). The deposit guarantee applies regardless of whether the credit balances consist of credit balances on interest-bearing or non-interest-bearing accounts or saving books.

Please also note in this regard the current information available on the website of Einlagensicherung AUSTRIA Ges.m.b.H. concerning the insolvency of Anglo Austrian AAB AG and the payout procedure: <https://www.einlagensicherung.at/aktuelles.php>. Additionally you should receive within the next days a letter from the Einlagensicherung AUSTRIA Ges.m.b.H. regarding this topic.

Your claims arising from – covered – deposits can be filed directly within the Einlagensicherung AUSTRIA Ges.m.b.H. which will, after verification, transfer the covered credit balance to a bank account specified by you. In case it is not possible for you to follow the instructions in the letter of the Einlagensicherung AUSTRIA Ges.m.b.H. (personal login for the payout website), please show up in person with the letter and an

official ID to the servicepoint set up at Anglo Austrian AAB AG, 1010 Wien, Bauermarkt 2, within the opening hours of the former bank (<https://www.angloaustrian.at/de/home>), which will help to file your claim.

In case your deposits with Anglo Austrian AAB AG are not covered or not fully covered by Einlagensicherung AUSTRIA Ges.m.b.H., a claim in the amount exceeding the covered amount can be filed with the commercial court of Vienna, AZ 5 S 29/20d. Further information is available on the websites:
